2015 was a record-breaking year for TMCA in so many ways and we have every reason to be optimistic about our future. This past year, our members enjoyed more than 35 events from our regular monthly meetings and dock parties to special events such as Mardi Gras in Galveston, the Nauti White Party, and the Commodore's Ball where we filled the Lakewood Yacht Club room to capacity. More than 550 boats participated in 35 cruises, even in spite of uncooperative weather at the beginning of the year. 130 boats and approximately 350 people went to Spring Fling at Pleasure Island in Port Arthur. We are approaching the 700 mark for dues-paid members and we are in the best financial position

ever in our 37-year history.

The numbers for 2015 are outstanding; however, they are not the only metric by which we measure our success. The main purpose of our club is to provide many and various opportunities to have a great time. You may have heard us jokingly say, "we broke the fun meter on this one!" 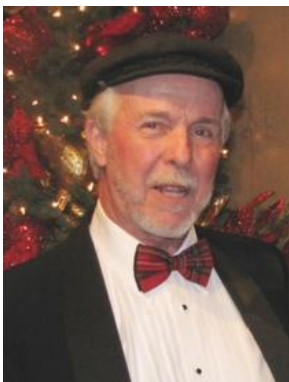
MAY YOU ALL HAVE THE BEST NEW YEAR OF YOUR LIFE IN 2016!

**Happy New Year!!!** And welcome to TMCA cruising in 2016!

It looks like our new Commodore, Jerry Simoneaux, wants me to keep writing this column for another year, and as I wrote last month, my involvement in the volunteer work that I have been engaged in, even before this committee was formed, was going to continue in any case, and so writing a monthly column to keep everyone abreast of things is not all that big of a chore. Representing the interests of recreational boaters to several maritime committees, and coordinating with representatives from various boating groups and other entities, is highly rewarding, and again, in our rapidly evolving port complex, there are a *lot* of things that can affect us adversely if none of us are on watch!!

1. For example, just recently I posted a notice on our TMCA yahoogroups site about a worrisome development that I became aware of on a waterway that TMCA cruisers sometimes frequent when doing down coast cruising. **The Friends of the Lydia Ann Channel** have just announced that their organization has filed a lawsuit against the United States Army Corps of Engineers regarding approval of an industrial barge fleet, storage, and service facility in the channel. <https://www.youtube.com/watch?v=xl7XQBxzcDQ>, and then information on the “FLAC” group itself at: <http://savelydiaann.org/>. Within that link it tells how one can “Get involved” and help their cause by expressing your feelings on this matter.

2. As I did all during 2015, at least for the first half of 2016 I will need to continue to keep everyone informed about the ongoing dredging project that is much closer to home in the Bayport ship channel. Officially it is known as the **Bayport Channel Deepening and Widening Project**, and when I recently checked [www.vesselfinder.com](http://www.vesselfinder.com), the dredge Richard LaQuay was still operating out in the bay alongside the channel, and the submerged dredge pipeline leading over to the disposal area on the east side of the HSC was still in place. The most recent map of the pipeline layout and the “recreational boater crossing area” can be seen by clicking [here](#), however my personal recommendation at this point, if you do happen to be cruising to the upper part of the bay, is to just skirt to the east around the entire work zone and then travel northward using the barge lanes of the HSC until you are safely past this potentially dangerous area.

3. Switching to a very serious topic that only *partially* relates to maritime issues, I bring up the threat of terrorism in this country. Within the past two months we have all witnessed the dreadful events of both Paris and San Bernadino, and since then there has been a lot of rhetoric about what this country is, or isn't, doing to combat the threat of domestic terrorism, whether foreign-motivated or not! Portions of our population are ready to believe that we are perhaps going to have San Bernadino-style terrorism events on a regular basis, and although firearms violence is an everyday occurrence in most of our cities, one's individual chance of becoming a victim of domestic *terrorism* borders nearly on zero! (Some statistics say that you have a much greater chance of being struck by lightning <http://www.lightningsafety.noaa.gov/resources/RecentLightningDeaths.pdf> } or eaten by a shark! [https://en.wikipedia.org/wiki/Shark\\_attack#Statistics](https://en.wikipedia.org/wiki/Shark_attack#Statistics)}) However..., having served for a decade now on the local **USCG Area Maritime Security Committee**, I can tell you with some degree of confidence that our port and our adjacent communities are I think better prepared for any kind of a terror attack than are probably most other areas of the country!

But it is the responsibility of us all to *help* the various governmental authorities keep us safe! Recently I have come across a whole spate of articles and web links that reinforce the important admonition: “**If you see something, say something!**” (<http://www.dhs.gov/see-something-say-something>) For example, regarding more land-based issues, there is this: <http://www.guidrynews.com/story.aspx?id=1000074276>. And then, in the most recent issue of the Local Notice to Mariners (<http://www.navcen.uscg.gov/pdf/lnms/lnm0851g2015.pdf> ) there is the following message:

#### **DEPARTMENT OF HOMELAND SECURITY SUSPICIOUS ACTIVITY**

The Department of Homeland Security (DHS) encourages the maritime public to report information concerning suspicious activity to the local Federal Bureau of Investigation Joint



Terrorism Task Force (JTTF) Office, [http://www.fbi.gov/about-us/investigate/terrorism/terrorism\\_jtfts](http://www.fbi.gov/about-us/investigate/terrorism/terrorism_jtfts), or to other appropriate authorities. The U.S. Coast Guard reminds the maritime industry that they may also report information concerning suspicious activity to the [www.AmericasWaterwayWatch.org](http://www.AmericasWaterwayWatch.org), the National Response Center (NRC) 1-800-424-8802 or 1-877-24WATCH.

There are many other links that I can provide on the topic, such as:

Also, when you are out on the water, be aware of where our local **USCG Security Zones** are located ([http://www.uscg.mil/vtshouston/docs/SECZONE8\\_5x14.pdf](http://www.uscg.mil/vtshouston/docs/SECZONE8_5x14.pdf) and [http://www.uscg.mil/vtshouston/docs/SECZONEfreeport8\\_5x14.pdf](http://www.uscg.mil/vtshouston/docs/SECZONEfreeport8_5x14.pdf)) and also know what “**MARSEC 3**” is (<http://www.lonestarhsc.org/docs/resources/USCG-Marsec-Levels.pdf>) and what the USCG *requires* of all of us boaters should that level of port security ever be called!

I could continue with more, but to summarize: “The Coast Guard also encourages members of the maritime community to participate in their local Area Maritime Security Committees. These local forums include representatives from the private sector, as well as federal, state, local and tribal governments. Maritime security is a shared responsibility, and the Coast Guard relies on the patriotism, vigilance and professionalism of the maritime community to help keep our nation secure.”

4. Now, switching to a less serious topic, monthly maritime history lectures for 2016 at the **Houston Maritime Museum** will be starting soon, and then usually occurring on the second Tuesday of each month. The first lecture, by HMM Collections Manager and Archivist Erica Peaslee on January 19<sup>th</sup>, will be entitled “**The Houston Maritime Museum: An Origin Story and Its Future**”. (Information on all upcoming HMM lectures can be found by clicking [here](#).) The museum provides sandwiches and beverages at these lectures, so come on out to see the amazing ship models and other objects in the museum, and learn about a bit of interesting maritime history. (And if you cannot make it to these lectures in person, videos are available online at by clicking [here](#). Check them out!)

I certainly don't wish to usurp anything from the January lecture, but there is some history about the museum on their website at: <http://www.houstonmaritimemuseum.org/history/>. I mention that because Jim Manzolillo, the museum's founder, was twice a speaker at TMCA meetings in the previous decade (he died in 2007). His life is a fascinating story, especially the part about his building shrimp trawlers in Mexico City!

Wishing everyone a fun and safe 2016 on our Galveston Bay waters, and beyond! Sorry that this was kind of a long column this month, but the port security stuff is obviously *very* important and I wanted to cover some of it as best I could! And as usual, if readers have comments, questions, ideas, or information on events that I may not know about, then I would definitely like to hear from you! Feedback is always *greatly* appreciated!!

Member further understands and agrees that during such cruises, Member(s) is solely responsible for the safe passage of his/her vessel(s) and for his/her full compliance with and observance of all applicable rules, regulations and laws of all applicable organizations and governments.

This application and Agreement shall constitute a binding agreement between the parties hereof and shall remain in effect until its expiration and/or termination of the membership, in accordance with the bylaws of TMCA.

You now have the choice to renew now by any credit card via PayPal (click **Subscribe**) or mail in a check (click **Pay Offline**)

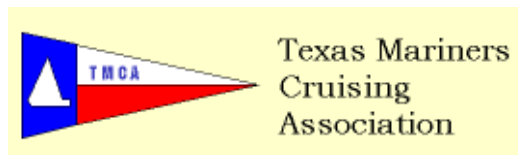
